The materials have been tested in accordance with the requirements of EC 10/2011 with regards to overall migration limits. Overall migration limits are within the specified limit of 10mg per 1 dm² for a cubic packaging containing 1kg of food to a migration of 60mg per kg of food.

HEAVY METALS:

Our suppliers state that cadmium, chromium (hexavalent), mercury and lead are not intentionally added during product manufacture. Any incidental amounts would not exceed 100 ppm by weight.
